Any withdrawals can be made before the scheduled date, provided the candidates sent their written consent by a hard copy letter or by EMAIL from his official EMAIL ID. Please refer to the ELECTION TIME – TABLE sent along with this Election Notice, for the SCHEDULED DATES related to the conduct of this FBS Election.

VALID VOTERS – Only FBS-IAP accepted members, on or before 31.03.2022, will be eligible to vote in the elections.

INSTRUCTIONS

Please make sure about eligibility for the applied post and eligibility of proposer and Seconder.

A member shall be ineligible for contesting for more than one post.

Read carefully all the details given in election notice, before filling up the Nomination Form.

Make sure all the particulars given are true, correct and as per records of the FBS-IAP office.

Eligibility Criteria of the Candidate for various posts are laid down, as under:

1. CHAIRMAN: Eligibility Criteria

The candidate must have accomplished **3 COMPLETE YEARS** of FBS Membership, from his Membership Acceptance Date up to 31st March, 2022. He should have been an All India Managing Committee Member for **TWO COMPLETE YEARS**, as on 31st March, 2022.

2. ZONAL VICE-CHAIRMAN (One from each of the FIVE ZONES): Eligibility Criteria

The candidate must have accomplished **TWO COMPLETE YEARS** of FBS Membership, from his Membership Acceptance Date up to 31st March, 2022.

3. HON. SECRETARY: Eligibility Criteria

The candidate must have accomplished **3 COMPLETE YEARS** of FBS Membership from his Membership Acceptance Date up to, 31st March 2022. He should have been an All India Managing Committee Member for **TWO COMPLETE YEARS** as on 31st March, 2022.

4. JOINT SECRETARY cum HON. TREASURER: Eligibility Criteria

The candidate must have accomplished **3 COMPLETE YEARS** of FBS Membership from his Membership Acceptance Date up to 31st March, 2022. He should have been an All India Managing Committee Member for **TWO COMPLETE YEARS** as on 31st March, 2022.

5. EXECUTIVE MEMBERS (STATE REPRESENTATIVES): Eligibility Criteria

The candidate must have accomplished **ONE COMPLETE YEAR** of FBS Membership from his Membership Acceptance Date up to 31st March, 2022.

Candidates should send their duly filled Nomination Form along with the **non-refundable nomination fee** mentioned against the post he / she is contesting for, by a DD drawn in favor of “**FAMILY BENEFIT SOCIETY**”, payable at Hyderabad, from a nationalized/reputed bank, **by Speed Post, Registered post & Courier shall be acceptable. GUIDELINES OF ELECTIONS:

- a. The election of the Office Bearers and the Executive Board Members of FBS shall be held by E-Voting as per the guidelines laid by the FBS CONSTITUTION.
- b. Any member, who has any complaint about the election, shall give the same in writing, addressed to
- c. Dr. U S Jagdish Chandra, The Chief Election Officer, FBS-IAP, 5-9-22/77, Adarsh Nagar, Hyderabad–500063, Telangana State, within 21 (Twenty one) days of declaration of the results.
- d. **Nominations:** The members may file as many nominations as they desire for a single post, however payment details should be made in all the nominations and the Xerox copy of the payment proof should be attached to all such additional nominations. The name of the candidate should be mentioned on the Nomination Form - as registered with FBS IAP Office records. No other change in the name will be allowed.
- e. A member cannot contest for more than one post. In such case, all the nominations of such member will be rejected as invalid. A member who is a Proposer / Seconder for a candidate cannot propose or second any other candidate in the current FBS ELECTION. In such case all the nominations proposed and seconded by same member will considered as invalid.
- f. **Casting of Votes:** The Voters are required to give a self attested Xerox copy of their Photo Identity such as PAN Card or Aadhar Card or Passport or Driving License along with the Ballot Papers. Additionally, he has to attach a self-attested photocopy of his FBS CERTIFICATE or FBS I-CARD. (as per recent amendments) His signature, in all the three documents, should be matching with the FBS Office records.
- g. **List of Voters:** The list of Voters will be frozen by the FBS Election Commission, based on the eligible voters accepted on or before 31.03.2022, as approved by FBS OFFICE.
- h. **E-Voting**
 - i. The names of the candidate will appear alphabetically on the ballot papers as per their names in the nomination form.
 - j. All correspondence and clarification in matters related to FBS elections will be sent or sought from THE FBS Chief Election Officer, directly and not through FBS office.
 - k. **Counting of Votes:** On the day of counting, FBS Election Commission shall keep a list of voters who have casted their votes in the FBS Election- 2023. They shall tick mark the list of those who voted. The FBS Chief Election Officer is empowered to rent out / purchase the requisite software as well personnel to handle this exercise. In case of more than one vote is found to be casted by any member, all such votes will be considered invalid and Chief Election Officer can recommend to FBS Managing Committee to take disciplinary action against such erring member.
 - l. Contesting Candidates or their representative (or both), coming with their identity proof are allowed to be present, during the counting of the votes.

NOTE: Any dispute shall be subject to **HYDERABAD** jurisdiction.


